This meant that £204.15 too much was paid to HMRC. This was reconciled in May by an underpayment of £204.15. JUNE 2023: 2) The RFO disclosed that he had paid £5 too much to Document Logic. This was reconciled in July by an underpayment of £5. 3) The RFO disclosed he had paid the same invoice to Document Logic for £36.75 twice. This had occurred because Document Logic put a stop on the Parish Account because of an unpaid bill (the Clerk had not forwarded this to the RFO); the RFO paid the unpaid bill but then forgot he had done so. This was reconciled in July by an underpayment of £36.75. 4) The RFO paid an invoice to SLCC but forgot to pay the £12 VAT compotent. This was rectified in July 2023 by an additional payment of £12.
