The defibrillators in Honley have been in place for 5 years and within that time we have had to replace batteries once in each defib and pads whenever they have been used. Sometimes the NHS defib team had raised funding to pay for replacements but 12 months ago they made us aware that their funds were reducing and they would need help. We replaced one unit that was stolen and repaired one that was damaged, all from HBA funding. Going forward we needed to raise funding so it became a community requirement with HBA holding the funding on behalf of the

community.

The most called for defib is attached to Taylors Foodstore and this is removed from the cabinet for possible use around once or twice per month.

Many times, it is returned without use but we have had to replace pads twice over the last 6 months.

Another one is on the wall of The Allied public house and has been removed for possible use around 3 times in the last 6 months but only once needed new pads.

The defibs need checking monthly to ensure their batteries are holding a charge and all is intact. We have a lovely crew of volunteers who do this, namely Taylors manager Chris, Oliver at Wired Coffee and Cake near The Allied, Andrea at Phoenix Park and myself June McLean with the other two at Magdale and Jagger Lane Rec.

In the recent questionnaire carried out in 2019/2020 in conjunction with Kirklees called "Ask Honley" we had over 12% of our population complete it and in answer to the question of "How safe is Honley" our village scored 6 out of 7 which we believe is due to the CCTV and the defibs showing our village cares about its community.

As the batteries can fail at any time we have the funds ready and waiting to replace pads and batteries as needed. Currently pads are £80 and batteries are £140 and with the fundraising we carried out with your grant and local donations we have around £3418.00 left and we have spent £522.49 over the last 12 months. We hoped the grant and monies raised would keep the defibs in good use for another 5 years. So if spending carries on at the same pace we should achieve that.

We should only spend the funding as the defibs require them as batteries and pads have use by dates so no point buying them for stock and then not using them due to date issues. So the funding needs to be available immediately, the defib is used to bring it back into use asap

### GENERAL

## PRICES

## TERMS OF PAYMENT

Unless otherwise agreed in writing by the Company payment shall be made in sterling without deduction of any kind whatsoever 30 days following delivery. In the absence of satisfactory references or in the case of default in payment and at the complete discretion of the Company the right is reserved to render proforma invoices to include an estimate for all charges due in accordance to be adjusted when the actual costs are known. These proforma invoices are to be paid prior to despatch of the goods. Proportionate payments shall be made for instalment deliveries. ## SPECIFICATION AND PERFORMANCE

All weights, illustrations, performance figures and dimensions given in quotations, catalogues, price lists, etc., are approximate only and not binding and the Company reserves the right to alter specifications or design at any time. ## INSTALL ATION

Unless otherwise expressly stated in the quotation, prices do not include installation

Provided the terms of payment are duly complied with, the Company undertakes to remedy any original defects arising from faulty materials or workmanship in any goods supplied by the Company which under proper and normal conditions of use may develop, provided the same are returned to the company as provided by this paragraph, within a period of twelve months from the date of delivery. In the case of components which by their nature of application have an unpredictable life this guarantee shall only be to the extent of the guarantee given by the manufacturers of these articles. The Company will accept no liability where in the opinion of the Company the defect has been caused by damage due to the Buyer's failure to follow operating instructions, incorrect installation, wear and tear or where the Buyer or any other person has undertaken any alterations or repairs without the previous consent of the company

### DAMAGE AND LOSS IN TRANSIT

## SPECIAL CONDITIONS APPLICABLE TO SALE OF GOODS OUTSIDE THE U.K.
